GENERAL DESCRIPTION

Steinel was founded in Romania in 1997, and since 1999 was founded at Curtea de Arges as a branch of Steinel Trading. Since 2009, it is in Curtea de Arges city, Arges county, as a stand-alone company - STEINEL ELECTRONIC SRL. The factory management agreed that SGS auditor to conduct confidential interview with workers; workers were selected freely by the auditor: directly from production and warehouse, during the visit, and from both shifts. The selection was without any influence by the factory management. Interviews are conducted in an independent place. For interviews were selected 4 groups of 5 employees and 10 individual workers. All records requested by auditor were presented and available. The selection was without any influence by the factory management.

The manager agreed to the examination of company records, so that audit was completed in the allocated time. All requested documents were presented without any reserve from management. It is ensured minimum wage, work overtime with worker acceptance, only. Of the total of 649 employees, 558 are directly employed by Steinel Electronic, and 91 temporary employees are through HR Systems (recruitment agency). All 649 employees benefit from the same rights that are found in the Collective Agreement. Employees through HR System have work contracts for specified periods and are extended according to STEINEL's needs.
